- -. Color Belt need 3 or 4 Boards with 3 or 4 techniques, it depends on your rank. Black Belt need 4 boards and 4 free style techniques.
- -. Board set up time is up to 30 second.
- -. Competitors may use a demonstration board for kicks above 360 degree and high technique breaking (Also acrobatic breaking).
- -. Never use a Chair, person or any other equipment to set up
- -. There are three chance for each breaking.
- -. 3 to 6yrs old Pee Wee board, 7 to 10yrs old Child Board, 11 to 14yrs old Teen Board, 15yrs old & up Adult Board
